**MODIFICATION OF OM NO. 6/2/2009-WELFARE DATED 20<sup>TH</sup> OCTOBER 2016 IN FULL COMPLIANCE  
OF HONOURABLE SUPREME COURT JUDGEMENT DATED 08<sup>th</sup> January 2016  
REMINDER**

With reference to our Letter no.NF/FM/F-01/17-18/05 dated 30th May 2017; most humbly we would like to inform you that till date we have not received any reply from your end in respect of resolution of our grievances raised before your good office. The facts and reasons for modification of the OM under reference was submitted before your augustself along with appropriate data collected from 23 Banks which are self explicit in nature to justify inadequate representation of SC/ST employees at all levels through the letter under reference. The decision of the Ministry as has been communicated vide captioned OM has therefore derailed the issue and needs immediate modification.

02. The data received by your department from all banks in response to OM No. 6/2/2009-WELFARE Dated 18/07/2016 is also not correct. In banks reservation is applicable upto JMGS I and concession upto MIMGS III. So Banks should have submitted data for the Officers upto Scale III who have been promoted or recruited availing reservation or concession excluding Officers in those categories selected on own merit. But all banks reported available Officers upto Scale III and upto Scale VI.


Therefore a rosy picture emerged and the matter has been closed by your department through the OM dated 20<sup>th</sup> Oct 2016 without resolving the deprivation faced by SC/ ST employees in Banks.

03. We therefore once again urge upon you to be kind enough to re examine the matter and issue modified OM extending reservation upto Scale VI level to ensure adequate representation.

We shall be waiting for your favorable decision.
